#### **Executive Director 2022 Report**

Lagea Mull reported that Annual Banquet attendance is estimated at 240. Raffle Sales and Dessert Auction brought in \$3,581. The Banquet After-Action Meeting is scheduled for April 5<sup>th</sup>. The membership count is at 129 with a total income received of \$33,750. There are 29 memberships whose renewals are outstanding. She shared that a grant request for 30 additional tables and 180 chairs was submitted to the Sweet Home Community Foundation.
